## NOTICE TO COMMERCIAL CONTRACTORS

**EFFECTIVE MAY 15, 2011**, the envelope hourly pay rate for all Building Trades Journeymen Sheet Metal Worker will be \$31.50 per hour, on an 8 hour day. **Foreman will receive an additional \$1.80 per hour and General Foreman will receive an additional \$2.30 per hour.**

- **The Working Assessment is \$1.71 per hour for every hour PAID** this amount includes \$.15 for Youth to Youth, \$.02 for SMOHI, \$.03 for the Building Fund, \$.01 for the scholarship fund, \$.03 for the Buffalo Bldg. & Construction Trades, and \$0.24 for the Market Recovery Fund.
- **A \$1.50 per hour deduction for every hour PAID** shall be forwarded to LU 71 Vacation & Holiday Savings Account after gross wages have been computed.
- **A \$.04 per membership contribution to PAL shall be deducted for every hour PAID** after gross wages have been computed.

**Each of the above deductions and contributions shall be forwarded, by separate check, to our office.**

- **Payment for use of personal automobile is \$ .51 (fifty-one cents) per mile.**
- The Travel Free Zone shall be Erie & Niagara Counties.
- Travel in the Counties of Orleans, Wyoming & Genesee shall receive \$12.00 per day.
- Travel outside the geographical jurisdiction of Local 71 up to 65 miles shall receive \$17.00 per day.
- All travel out of Local 71 Jurisdiction over 65 miles will be subject to rates published by the IRS under **Publication 1542.**
